A Message from the Executive Director

Vermont's housing crisis is no longer a distant problem – it is here, and we see its impact every day at Charter House. Our community depends on us to meet that crisis with compassion, creativity, and persistence. This past year, we chose to put people first – our guests and our staff – even as federal and state funding held flat or declined. That decision meant operating at a deficit. While reserve funds allowed us to cushion that budget impact, sustaining our mission will require new, reliable funding sources to match the scale of the crisis.

At the same time, we can take heart by recognizing the good, hard work of our guests, staff, and volunteers. Every day we are reminded of Eleanor Roosevelt's wise words: "You must do the thing you think you cannot do." In a year defined by challenges, we have leaned into that philosophy – staying focused on the needs of people, not the politics of the day – and we've witnessed life-changing outcomes.

Behind every number in this report is a story. One guest, after 600 days in shelter, worked full time, met all criminal justice requirements, and still faced closed doors in the rental market. Together with our staff, they pursued a new path: a first-time home buyer's mortgage. The day they left our shelter was the day they moved directly into their own home. Two others found housing in just 27 days, discovering new possibilities they hadn't imagined before.

Our staff, too, embody persistence and creativity. One conceived the idea of building a greenhouse on our property to expand our vegetable garden's growing season. With the help of a private foundation grant and funding and physical labor provided by our local Rotary Club, the greenhouse now stands ready to provide fresh produce, therapeutic activity, and community – we plan to be digging in the dirt, even in March.

And we continue to invest in our people. For years, staff worked without benefits. Step by step, we changed that – first medical coverage, and this past year the addition of dental, vision, retirement, and Employee Assistance Program services for staff and their households. Supporting those who carry the weight of trauma work is vital to our mission.

All of this is part of a larger story. Charter House has grown into a million-dollar operation, driven by the sharp increase in homelessness across our state. Our professional staff and volunteers expanded services in shelter and street outreach that literally saved lives. We responded to emergencies, but we also pressed forward toward long-term solutions – models of housing and services that lift people out of homelessness altogether.

It has been a challenging year, but it has also been one of deep accomplishments. We are grateful for your partnership, your trust, and your generosity. Together, we are building a community where no one is left outside.

How We Help People

We operate an **emergency shelter** for adult men and women who have no other options for a safe place to sleep. We actively support those who stay with us in the search for a stable, affordable home.

Our **community meals program** serves a nutritious meal every day of the week to anyone who comes to our door, 365 days a year.

We offer **employment** support and guidance, helping people find and keep a job.

We focus on **individuals**, developing a personalized action plan that lets each person move forward with confidence and hope for long-term success.

We are a **communication hub**. Our phones are answered 24/7 with a dedicated staff member on call at all times. We coordinate with local partners for referrals and services. We do regular street outreach to connect with individuals in need.











How Much We Help People

The number of individuals served in the emergency shelter increased to 188 this year, up from 144 in FY24, and 88 in FY 23. The total number of people served by all programs was 597.

We served 28,000+ meals to people staying at the shelter or coming to the door for take-out.

42 people from the shelter and outreach programs secured permanent housing.

30 individuals secured employment within 28 days of entering the shelter.

People with disabling conditions, such as substance abuse disorder or mental or physical health conditions, increased to 102 this past year, up from 58 the previous year.

We answered 1,700 calls outside of normal business hours.
